NO OBJECTION AND CONDITIONAL APPROVAL: WIN LONG TAEKWONDO MARTIAL ART & TEAM DEMO INVITATIONAL CHAMPIONSHIP 2026

We refer to your letter requesting Taekwondo Malaysia (WT)'s no objection and support for the Win Long Taekwondo Martial Art & Team Demo Invitational Championship 2026.

Taekwondo Malaysia (WT), as the national governing body for Taekwondo in Malaysia, hereby grants conditional approval for the organisation of the following event:

EVENT	Win Long Taekwondo Martial Art & Team Demo Invitational Championship 2026
DATE	6 to 7 June 2026
VENUE	City Square Shopping Mall, Johor Bahru
ORGANISER	TM Instructor and Black Belt Committee and Win Long Taekwondo Club

This approval is strictly subject to the following mandatory conditions:

1. Participant Registration

All Malaysian participants must be duly registered with Taekwondo Malaysia (WT) through its recognised affiliates, namely State Associations, Premier Clubs, or National Institutions.

2. Compliance with Governing Rules

The organiser shall fully comply with Taekwondo Malaysia (WT)'s Constitution, By-Laws, Code of Ethics, and all applicable rules and regulations. Any breach may result in immediate revocation of this approval.

3. Scope of Event (Strict Limitation)

As this is a martial arts-based event, the organiser shall not organise, include, or permit any sport Taekwondo (kyorugi) events under any circumstances.

4. Regulatory Oversight – Kukkiwon & Committee Jurisdiction

This event falls strictly under the purview of Taekwondo Malaysia (WT)'s Instructor and Black



Belt Committee. All events conducted must be limited exclusively to Kukkiwon-recognised disciplines and shall strictly comply with the Hamadang Rules and Regulations.

5. Supervisory Authority

Taekwondo Malaysia (WT) has appointed Grand Master Mai Chee Keong as the Competition Supervisory Board (C.S.B.). The C.S.B. is vested with full authority to supervise the Championship and to take immediate corrective or disciplinary action, including suspension of events, in the event of any non-compliance.

6. Costs and Allowances

The organiser shall bear the allowance of the Technical Delegate (T.D.) and Head of C.S.B. at RM200 per day, together with transportation costs at the rate of RM0.70 per kilometre. Taekwondo Malaysia (WT) further reiterates that while it is responsible for the development of sport Taekwondo in Malaysia, it also supports the development of martial arts Taekwondo under the purview of Kukkiwon, subject always to proper governance and regulatory compliance.

Failure to comply with any of the above conditions shall result in immediate withdrawal of this approval without further notice.

We trust that the organiser will adhere strictly to the above requirements and uphold the standards and reputation of Taekwondo Malaysia (WT).
